


CELEBRATING 2023 HONOREE

Hermann Colas, Jr. is a proud Haitian, American, and Veteran. After serving in the Vietnam War, Hermann became a distinguished scholar and civic and business leader dedicating his life's work to strengthening communities. Hermann's story began in 1948 in Port-Au-Prince, Haiti, where he learned how to lead as the eldest son of eight siblings. His love for his family and the family home inspired his career path and mission, eventually leading to the founding of Colas Construction (COLAS), a general contracting firm headquartered in Portland, now owned and operated by the second generation. Today, his impact on countless families remains clear with an impressive portfolio of housing, tenant improvements, and renovations. COLAS is nationally and locally recognized for delivering excellence in construction for a diverse scope of housing, education, civic, and healthcare projects.

Telling the story of her ancestors through her art – whether large-scale public art installations or smaller pieces of intricately designed jewelry – Lillian's work is all around us. By encouraging and cultivating the next generation of Native American artists as a deeply committed mentor, Lillian is ensuring that the Indigenous story of Oregon is remembered and honored.



Carol Edelman

Throughout her career, Carol Edelman has worked on projects across the Northwest from the redesign of Crater Lake Lodge to the Visitor Center at Mount St. Helens. Perhaps what sets Carol apart from her peers is not only that she was a woman breaking into a field historically dominated by men, but she regarded her work as just one part of her service to Oregon's community. She has played a vital role in the arts community in Portland by supporting numerous organizations like PNCA and Portland Piano, among others.

Each year, teachers across Oregon help AFO deliver our Architects in Schools program to approximately 5,000 elementary school students. Together with volunteer design and building professionals, they are AFO's first responders and we couldn't bring the power of design to Oregon kids without them. Architect and urbanist Don Stastny has elevated the design process as a problem-solving tool on local and national stages for over five decades. He conducted the design competition that created Portland's Pioneer Courthouse Square and designed PSU's Native American Student and Community Center. Don is recognized for utilizing the power of design to define the intersections of cultural, economic, and environmental systems, promoting a sustainable built environment that is both visionary and respectful of those it serves.



Lee Kelly Visual Arts 2016

Lee Kelly's contributions to Oregon's designed and built environment are visible throughout Oregon as you drive along the freeway, stroll through the park, or hurry to class on campus. More than 30 of Lee's monumental sculptures command public spaces between Eugene and Vancouver. His works are on nearly every public and private higher education campus in Oregon. Lee was a national treasure whose work has enriched Oregonian's lives for more than five decades.


Arlene & Jordan SchnitzerPhilanthropy

Art Johnson Engineering 2014

One of the most respected structural engineers in Oregon, Art Johnson was a creative design problem solver, a gifted mentor and teacher, a successful design business industry leader, and a great humanitarian. Art built the premiere structural engineering office in the region beginning with KPFF's Portland office opening in 1974. His signature is on many of the most structurally complex buildings and infrastructure projects in Oregon and across the globe, including the Oregon Convention Center and Doernbecher Children's Hospital.



Benson IndustriesManufacturing

Some of the most intricate and interesting building systems in Oregon and throughout the world feature the design and fabrication of this global leader's curtain wall systems. Begun as a small Portland residential window company in 1926, Benson is a coveted partner of world-renowned architects, contractors, and owners. AFO recognized their contributions to design from McMinnville's Evergreen Aviation & Space Museum and Water Park to the stunning Towers One and Four at the World Trade Center in New York City.



Phil & Penny Knight
Philanthropy

Nike Co-Founder Phil Knight and his wife, Penny, are perhaps Oregon's most generous and recognized contributors to the designed environment, understanding excellent design's impact on improving quality of life as a guiding force for their philanthropic investments. Penny recently donated \$550,000 to AFO in honor of Lillian Pitt to establish the Tsagaglalal Scholarship for Native American, Alaskan Native, and Hawaiian Native students pursuing a degree in Art or Architecture at Portland State University.

Known as "The Best Bike Ride in America" for offering unparalleled scenery, challenge, amenities, camaraderie, and philanthropy, Cycle Oregon also makes tremendous gifts to Oregon's built environment. AFO paid tribute to Cycle Oregon for celebrating the richness of Oregon's landscapes, small towns, and open spaces, and for the organization's philanthropic gifts to the communities it visited, many of which resulted in repairing or creating public recreational or other infrastructure in small towns, rural, and metropolitan communities.



Dave Frohnmayer Visionary Leader 2009

During his 15-year tenure as University of Oregon president, Dave Frohnmayer raised more than \$1 billion in private philanthropy for UO and added a host of new centers and institutes. The construction cycle during his tenure saw approximately \$500 million in projects completed. Dave eloquently expressed his laudable views on leadership, citizenship, and the Oregon we love. His connection of the built environment to the transformation of lives for thousands of UO students is a story of its own.



John D. GrayDevelopment
2008

AFO celebrates John Gray as the developer who taught us how to build in concert with the land. Specializing in environmentally sensitive property development, John developed Salishan Lodge and Salishan Hills on the Oregon Coast, Sunriver in Central Oregon, Johns Landing in Portland, and Skamania Lodge on the Washington side of the Columbia River Gorge. He was known for his respect for how we develop our state to accommodate those of us who choose to live here alongside the creatures who came before us.

Earl Blumenauer Advocacy/Public Official 2007

A life-long Portland resident and long-time veteran of the U.S. House of Representatives, Earl Blumenauer has devoted his entire career to public service. His hard work has produced many benefits for Oregon, securing millions of dollars to fund projects for MAX light rail and streetcar, bridges, trails, pedestrian facilities and street improvements, protections for the Little Sandy watershed and Mt. Hood, and support for local farms. AFO is one of many organizations to recognize Congressman Blumenauer's many accomplishments.



Bob GerdingDevelopment

Bob Gerding was widely known for his contributions to Oregon's built environment as one of the state's leading developers. Those who knew Bob know that his emphasis was more on 'contributor' than on 'developer.' Known for the passion he had for everything he undertook, AFO celebrated him for his vision and leadership, his volunteer and philanthropic activities, and the community he created, both physically and spiritually, that continues to make our state a better place for all.



Mike Houck Landscape/Environment 2005

Dedicated to maintaining habitats for wildlife in our urban areas, Mike Houck has maintained a vigilant and vocal crusade for more than 25 years. During that time, his work has grown from a focus on environmental issues to a broader advocacy for a wide range of important urban and natural resources for the region. He has advocated for affordable housing, a rational metropolitan transportation system, the restoration of urban waterways, and the strong urban wilds system.



Robert Frasca, FAIA Architecture/Interiors 2004

As partner-in-charge of design for ZGF Architects beginning in 1966, Bob Frasca transformed the face of Oregon's built environment, exported our Northwest aesthetic internationally, and advanced the legacy of design excellence through mentoring countless talented young architects. Bob's work is united by his belief that architecture should vary with the program, climate, and place, and with the culture of the people who will occupy it. His instincts as an observer, and then as a designer, produced a diverse portfolio over his career.

Jean VollumPhilanthropy
2003

An Oregon treasure widely recognized for her many contributions to education, culture, humanities, and natural resources, Jean Vollum and her husband, Howard, were responsible for architecturally significant sites and buildings in Oregon. Her foresight created the nation's first LEED Gold-rated historic restoration, the Jean Vollum Natural Capital Center, and PSU's Native American Student and Community Center. Through design, Jean made it possible to further the missions of the institutions that the buildings house.



Peter O. Kohler, MD Visionary Leader 2002

Serving as president of OHSU from 1988 to 2006, Dr. Kohler was responsible for countless accomplishments at the university during his 18 years of service. A book by William Graves documented Kohler's career as OHSU recounts the dramatic turnaround of the institution under his watch, including more than doubling research, clinical, and classroom space; tripling the number of employees; quadrupling research grants; and expanding the operating budget five-fold.




Ed Carpenter Visual Arts 2001

Working from his Portland studio since 1973, Ed Carpenter has completed countless sculptural, architectural, and infrastructure projects and installations worldwide. Ed is known for his variety in design, material use, and approach, often using light as a guiding principle, including self-described ground-breaking use of programmed artificial light. Ed has been recognized with a host of awards over his 50-year career, most recently for his design of the Barbara Walker Crossing for the Wildwood Trail, completed in 2019.



1000 Friends of Oregon Advocacy/Public Official 2000

With a mission of "...working with Oregonians to enhance our quality of life by building livable urban and rural communities, protecting family farms and forests, and conserving natural areas," 1000 Friends of Oregon was founded in 1974 by Henry Richmond and former Governor Tom McCall. In addition to preserving Oregon's urban and rural land, farmland, forests, and food systems, the organization promotes affordable housing and aims to improve transportation systems through the lens of land use leadership.

Neil Goldschmidt Advocacy/Public Official 1999

Over the course of three decades, Neil Goldschmidt held office at the local, state, and federal levels, serving as Oregon Governor from 1987-1991, and briefly serving as U.S. Secretary of Transportation in the Carter Administration. As Portland Mayor from 1973-1979, he helped to stop the proposed Mt Hood Freeway and was instrumental in establishing the MAX light rail system and Portland Transit Mall.



Tom Hardy Visual Arts 1998


One of Oregon's most accomplished artists, Tom Hardy spent over 50 years as an artist and teacher, paying homage to the natural beauty of the state through his art and work - watercolor, ceramics, and metal sculpture among his preferred media. Tom enjoyed early success with exhibits in local art museums. His work went on to find homes in major museums nationwide, with the pinnacle of his career being the 1997 commission for a bronze eagle seal at the Franklin Delano Roosevelt Memorial in Washington, D.C.



Mark O. Hatfield Advocacy/Public Official 1997

Serving as Oregon Secretary of State, Governor, and U.S. Senator across a career spanning nearly five decades, Mark Hatfield is remembered as one of Oregon's most prominent and important politicians. Among a mountain of career achievements, some of his most notable include the bolstering and transformation of OHSU, the creation and implementation of Portland's MAX light rail system, and the protection of Oregon wilderness areas, including the designation of the Columbia River Gorge National Scenic Area.



Pietro Belluschi, FAIAArchitecture/Interiors
1996

AIA Gold Medal award-winning architect Pietro Belluschi was one of the most prolific architects to call Oregon home. The state is graced with numerous buildings - from homes to churches to high rises - designed entirely or in part by Pietro. His influence was felt across the world, making significant contributions to modern architecture both in the International Style, and the Regional Modernism of the Pacific Northwest. By his own estimate, Pietro designed over 1,000 buildings in the course of his career.

Dr. Francis Newton Visual Arts 1995

Beginning his career with the Portland Art Museum as Curator in 1953, Dr. Francis Newton went on to serve as Director of the museum from 1960-1975. Under his leadership, the museum saw notable exhibits by Van Gogh and Picasso, added the Monet painting, "Waterlilies," to its collection, and saw the completion of the Hoffman Memorial Wing in 1968, designed by 1996 Honored Citizen honoree, Pietro Belluschi. Francis is remembered for his kindness, intelligence, sense of humor, and generosity.



Barbara Fealy, FASLA Landscape/Environment 1994

Known as the "matriarch of landscape architecture in the Pacific Northwest," Barbara Fealy's career in Oregon spanned nearly five decades. Her career highlights include Salishan Lodge, Lewis Residence, and Timberline Lodge, which was listed in the National Register of Historic Places in 1973 and designated a National Historic Landmark in 1977. Barbara was named a Fellow of the American Society of Landscape Architects in 1985, the first woman in Oregon bestowed with that honor.



Leroy SetziolVisual Arts
1993

Leroy Setziol is known as one of the most accomplished and respected wood sculptors in the Pacific Northwest. For over 50 years, he carved works ranging from small and intimate to large-scale public commissions. One of his most notable projects was a series of large-scale panels for Salishan Lodge, working with famed architect John Storrs. This garnered greater recognition in Oregon's architectural community, in which Leroy collaborated with several leading architects throughout his illustrious career.
